#### PROPOSED REVISIONS/ ADDITIONS TO THE ARCHITECTURAL RULES

At the Board of Directors meeting held on March 27, 2013, the Board approved sending the following revisions of the Architectural Rules to the membership for the required 30 day review and comment period. Any comments or concerns should be put in writing and submitted prior to April 30th when the revised Architectural Rules will be formally adopted.

Amend Architectural Rule 3.14, Fences and Walls to include: "The height for all walls and fences described in this rule shall not exceed the maximum specified height, when viewed from either side and when measured from the adjacent property, in accordance with City of WLV Municipal Code 9.14.050."

California Fish and Wildlife Code Section 2300-2302 WLMA RULES: No watercraft, (ex. boat, kayak, canoe, float, model boat or any other object, may be launched by any person (member, lake user, vendor, anybody) onto the Lake without the prior visual inspection and approval of the Lake Manager, written proof of current liability boat insurance, and, thereafter, the issuance of a valid permit sticker placed on the watercraft. If any permitted watercrafts are removed from the Lake you cannot relaunch without new written permission from the Lake Manager.

#### **SPRING FLOWERS**

Our rains were sparse this year but enough fell to produce wonderful results in Lakeshore. Daffodils, roses, lilies, geraniums, irises, daisies and more flowers can be seen blooming in yards all over Lakeshore.



But where did all those weeds come from? They are growing just as robustly or even more vigorously than the beautiful spring flowers. Please tend to the weeds soon with your hoes, cultivators or spray with Roundup or your favorite herbicide.

And remember that you are responsible for those weeds at the curb next to the street. You thought the City took care of that? Don't hold your breath, it's not true. Actually a State of CA law , (Sts. & Hwys. Code § 5600) makes you responsible for maintaining the easement in front of your home all the way to the street.

Now that frost danger is behind please cut back those ugly brown portions of your plants that froze. We hope as much as you do that they will spring back. But please remove and replace all plants that have completely died during this winter's tough frost.

Local nurseries are all having sales right now, but remember when choosing plants that Lakeshore gets a few degrees cooler than parts of many neighboring communities.

Choose replacement plants carefully with an eye to frost hardiness to 20° F. They should be suitable for Sunset's cold-air basin Climate Zone 20 or the USDA Plant Hardiness zone 8b. Visit <a href="https://www.sunset.com/garden/climate-zones">www.sunset.com/garden/climate-zones</a> to view a map.
