HOME REPAIR COSTS HELP

The City of WLW provides house rehabilitation grants up to \$5,000 for residents. The program is operated with funds available from U.S. Department of HUD. Eligible participants must be the owner and occupant of the home as a principal residence. Several Lakeshore residents are past recipients. Eligible residents may receive grants for repairs. Examples of eligible projects include: water heater replacement, electrical and plumbing repair, handicap accessibility, heating/air conditioning and repair work to correct leaking roofs and siding. Residents are encouraged to call 818-706-1613 for information and to determine eligibility. All residents that meet qualifying guidelines will be added to the current waiting list on a first-come, first-served basis.

ARCHTECTORAL APPLICATIONS

Remember, before you build it, landscape it, paint it or make any changes to the exterior of your house you are required to submit an architectural application and receive approval. The purposes of these Architectural Rules are to provide positive guidelines for the continuation of the harmony and beauty of our community while preserving the value of the investment that all of us have in Lakeshore. These purposes include:

- ◆ Avoiding problems involving changes that may affect the common areas, including views of the Lake
- ◆ Preserving the congruous appearance, variety and individuality of Lakeshore's architectural integrity
- ◆ Considering the aesthetic and functional aspect of any design change(s)
- ◆ Minimizing oversights caused by owners or their contractors, who may be unaware of the needs and concern of the Association, community and neighboring homes.

Violation of these Architectural Rules could result in fines, suspension of privileges, and/or legal action for which you could be held responsible per CC&R § 1.33.

St. PATRICK'S DAY CELEBRATION

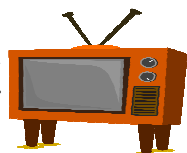

WOOD SIDING CONCERNS

Three of the siding materials used in Lakeshore are wood and the fourth was stucco. Individuality and uniqueness was created by the builder using different colors, materials, roof geometry, front and rear set backs and landscape. Lakeshore's look is unique to townhomes in the area, unlike those that are all the same color, material and shape - the "condo look".

Western Red Cedar Lumber Assoc. and others state the average life span for wood siding is 30 to 50 years. If you still have original 1968 wood siding, plan for replacement soon. More than half of Lakeshore's wood siding has been replaced and the rest are near end of life. The west and south facing sides will be the first to show wear because of direct exposure to the sun's UV rays. Resist the temptation to repaint worn out wood. New paint won't last long if the wood is worn out.

Lakeshore's rules require replacing siding with the same style as the original, i.e. shingles, clapboards, verticals. Several years ago we allowed stucco as a replacement for wood but stopped when it was seen that Lakeshore was starting to take on a "condo" look. We want to preserve the "Lakeshore look."

Materials other than wood are being approved, such as vinyl, composition "engineered" wood, and fiber concrete. However, wood still usually turns out to be most economical. Another consideration is that concrete holds heat from summer's sun while wood does not.

Please inspect your home siding now, ahead of Lakeshore's annual CC&R mandated Walk-Through inspection. See what needs fixing. Many contractors raise their prices during the hot summer months.

Bonus Tip: Siding may only be required for two sides depending on what direction your house faces
