ONLINE MAIL TRACKING

Mail tracking is now available through the United States Post Office!



With incidences of mail theft increasing, the USPS has introduced Informed Delivery. This is a national online service that, each mail delivery day, sends images to subscribers of the front of up to 10 letter size pieces of mail. The service lets users know to expect an important piece of mail and if it doesn't arrive. If there are more than 10 items scheduled for delivery, the subscriber can visit their account page at the Informed Delivery website to view the remainder of the items.

ARCHTECTORAL APPLICATIONS

Remember, before you build it, landscape it, paint it or make any changes to the exterior of your house you are required to submit an architectural application and receive approval. The purposes of these Architectural Rules are to provide positive guidelines for the continuation of the harmony and beauty of our community while preserving the value of the investment that all of us have in Lakeshore. These purposes include:



- ◆ Avoiding problems involving changes that may affect the common areas, including views of the Lake
- ◆ Preserving the congruous appearance, variety and individuality of Lakeshore's architectural integrity
- ◆ Considering the aesthetic and functional aspect of any design change(s)
- ◆ Minimizing oversights caused by owners or their contractors, who may be unaware of the needs and concern of the Association, community and neighboring homes.

Violation of these Architectural Rules could result in fines, suspension of privileges, and/or legal action for which you could be held responsible per CC&R § 1.33.

RULE REMINDER— 3.16 OUTDOOR LIGHTING



The Board would like to take a moment to remind you of Lakeshore Architectural Rule 3.16 Outdoor Lighting.

Outdoor Lighting. Applications are required for new exterior lighting. Only soft or warm white light bulbs, typically labelled 2700 to 3000K, may be used. No colored bulbs or lenses, nor cool daylight or bright white bulbs are allowed. All exposed wires, except landscape strings, must be concealed. Maximum height above ground for fixtures affixed to houses, balconies or patio covers is 10' and for bushes and trees 6'. One exterior balcony light is allowed. Lighting should be shielded or shaded and not directed onto neighboring properties. Holiday lighting, including colored or white lighting is allowed between dusk and 11:00 p.m. starting after Thanksgiving until the second Sunday of the New Year.

RATS IN LAKESHORE?

Rats in Lakeshore? Yes. Two different types live here. Sewer rats, aka browns or Norwegian, and roof rats. They are here because Lakeshore provides lots of appealing food and drink for rats. They can nap and spend the days in our warm garages, attics and certain trees and bushes, especially Italian Cypress and Junipers, while feeding mainly at night.

Lakeshore's exterminator, Ventura Pest Control, tells us the following about controlling our rat population:

- Get rid of the number one source of rodent food, bird feeders. Rats love seeds.
- Feed all pets indoors.
- Trim all fruit trees and remove ripe fruit
- Trim all trees 3 feet away from house
- Trim ground cover 12 inches from house

Rats need one ounce of water per day plus food and a place to hide. You need to do your part to discourage these rodents from occupying and reproducing in Lakeshore. Compliance with these rules is based on *Lakeshore Rules & Regulations § 4.2: Members shall keep their lots, residences and all improvements clean and sanitary.*

We look forward to your assistance in helping the Association control these disease carrying rodents, who can also cause severe damage to wiring in both our homes and vehicles as well as to siding and roofs.

DON'T FORGET TO "SPRING FORWARD"

On Sunday, March 8th at 2 a.m., Daylight Saving Time officially begins.

Local fire agencies recommend changing batteries in smoke detectors and checking your fire extinguishers when clock times are changed. In addition, check your emergency supply kit to make sure it is fully stocked and ready
