WLMA REPORT

Water clarity remains strong and averaging 7ft throughout the lake. Last year at this time, the range was approximately 2-3 ft and planktonic algae outbreaks affected the water clarity significantly. The first application of ALUM Sulphate has helped with the control of the algae. In addition, water continues to flow over the dam and when that subsides, Wells 1 & 2 will then be activated.

Lake maintenance crew have been working diligently on picking up the dead and loose pond weed floating on the lake. The increased water clarity and more sunlight being able to penetrate through the water has enabled the aquatic grasses and pond weed to flourish. This is a great sign as to the health of the lake.

The 4th of July went smoothly, and Lake Patrol did an outstanding job making sure everyone stayed safe and executed boat tows throughout the day and night for those in need.

Lake Management will be installing a 6 x 8 ft. portable building at the launch ramp gate that will be manned by a part-time WLMA employee who will be monitoring every boat that comes in and out of the lake. This will ensure the boats are dry (Quagga Mussel control) and registered with attached stickers with the proper address and slip.

SAFETY - It is imperative when using your boat at night to use your navigation lights, both bow and stern, and must be in good working order. This is one of Lake Patrol's biggest issues and letters will be sent to boat owners whose navigation lights need repair or replacement done within a timely manner. Retired Rear Admiral Tim Sullivan will be kicking off the first of its annual Emergency Action Plan (EAP) training meetings in August with WLMA. This is to ensure the understanding of EAP and procedures if an emergency event were to occur.

Aqua Thruster aerators continue to be installed on the cul-de-sacs of inlets to help with keeping the water moving to prevent algae and scum buildup. Congratulations to WLMA Manager Nick Smith and his crew for keeping our beautiful lake pristine and keeping things running smoothly on the lake. Stay safe everyone!
