WLMA LAKESHORE REPORT: Submitted by Lynda Brenner

As we approach the end of 2023, the lake management efforts for the lake continue to yield positive results. A second application to treat Brittle Naiad weed has been successfully administered, contributing to the preservation of the lake's ecological balance. In addition, with the days getting shorter and morning/night temperatures dropping, the Brittle Naiad will naturally die off.

The Brittle Naiad issue around Lakeshore and the first two inlets of Southshore received a second round of treatment and has proved effective to curtail the growth. Regular monitoring and assessment will continue over the next few weeks to ensure that no further issues are identified. Growth of different varieties of aquatic weeds were expected this year as needed to reestablish the ecology of the lake which also includes Charra or Muskgrass to be given the chance to grow on the lake floor which has now established a solid base.

Throughout October, there was a small consistent flow of water over the dam and Wells 1 and 2 have not needed to be activated. However, if there is not much rain throughout the month of November, the lake level could drop an inch or so and may need to activate the wells. WLMA is happy to report Well #4 is now operational should it be needed in the future.

Upcoming plans and continuation of projects include; auditing boats for upcoming billing, continue replacement of boat stickers, shoreline repairs, carp management, marina software integration, water quality monitoring, dam channel cleanup and trimming cattail growth.

As you have read, our lake management team is kept quite busy maintaining our beautiful lake every day. Until next time.... stay safe on the water.
