WLMA LAKESHORE REPORT: Submitted by Lynda Brenner

Did you know this is the 50th anniversary for WLMA? It all started in 1974 and I had the pleasure to listen to guest speaker Frans Bigelow at the last WLMA board meeting on February 20th tell the story. He also was the first lake manager and told us we even had carp way back then! (But at least we have them under control now.) In addition, Frans traveled across the country giving lectures while describing how incredible our lake is as many others wanted to hear how we were able to maintain its beauty. I learned quite a lot about our lake that evening and hope to share more with you along the way.

With the amount of rain this month, the lake level is high thank goodness, but the rain has brought a lot of debris into the lake. Lake Patrol has been extremely busy collecting all the debris especially around the Westlake Bay and Lakeshore communities.

Clean Lakes Inc. provided their monthly inspection that included the collection of water samples on January 23, 2024. The average water clarity in January was 5.75 feet in comparison to water clarity measured this time last year was 4.0 feet. A probiotic muck remover was applied at two locations which is designed to reduce the accumulation of organic material on the lake bottom. Applications are scheduled to continue bimonthly.

There were no sign of midges observed during the regular lake inspection and no midge control applications carried out in January. Monitoring will continue as part of the weekly lake inspections. Golden algae were tested in January and the results will be reported next month after they are received. There were no other algae treatments carried out in January.

Will report more updates in March.

MOSQUITO PREVENTION

Spring is the season for mosquitos. Helpful hints you can take to prevent mosquito breeding on your property:

- Destroy or dispose of tin cans, old tires, buckets, unused plastic swimming pools or other containers that collect and hold water.
- Do not allow water to accumulate in the saucers of flowerpots or in pet dishes for more than 2 days.
- Clean debris from rain gutters and remove any standing water under or around structures, or on flat roofs. Check around faucets.
- Change the water in birdbaths and wading pools at least once a week and stock ornamental pools with top feeding predacious minnows.
- If swales/ditches do not flow and contain stagnant water, they can produce large numbers of mosquitoes. If you have a swale area that runs next to your property, please be sure to keep free of standing water and if you see this condition in any common area, report it to The Emmons Company.
